#### **About Jill's House**

Jill's House, a full-service overnight respite center, renews families through much-needed breaks while providing a safe, fun environment for children with special needs. This innovative 42,000-square foot, 45-bed respite resort for children ages 6 to 17 with intellectual disabilities and their siblings, is located in the Washington D.C. metropolitan area, providing restoration to families of all faiths and backgrounds. Jill's House also serves families in Texas, Indiana, California, and Arizona through local partnerships. Receiving no direct state or federal funding, Jill's House was created and is maintained through individual donations and grants.

#### **The Need and Impact of Jill's House since opening in October 2010:**

- Since 2010, Jill's House has provided nearly 500,000 hours of hope and renewal to 600 families, 10% of whom serve in our military.
- Of the children we serve, 50% have autism spectrum disorder (ASD); 20% have Down syndrome; 10% have a chromosomal disorder or genetic abnormality; and 20% have a wide array of diagnoses from cerebral palsy to brain injury.
- Every day a new family registers their child to stay at Jill's House.
- More than 40 families are currently on the wait list to get in to Jill's House.

**About TPC Potomac at Avenel Farm**

The reviews following the \$20 million renovation of TPC Potomac at Avenel Farm speak for themselves. Shortly after reopening in 2009, TPC Potomac was ranked No. 14 by Golf Digest - Best Courses in Maryland, #12 by GolfWeek Magazine - Best New Golf Courses (2009) and also listed among Links Magazine's list of Best New Golf Courses for that year. Challenging enough for the best players in the world, the golf course offers five sets of tees on each hole affording golfers of all abilities the chance to "Play it Forward" and experience an enjoyable round of golf. The par 70 golf course measures 7,139 yards from the championship tees, but from the member tees is a fair challenge at around 6,047 yards. Quicken Loans National will be played at TPC Potomac at Avenel Farm in Potomac, Md., during the PGA TOUR's 2016-2017 season.
